### DIRECTIONS FOR USE:

**TRUCK/TANK SPRAYERS:** FILL TANK HALF WITH WATER, ADD PRODUCT THEN REMAINING WATER FOR GOOD MIXING. 32oz MAKES 250 GALLONS. 16oz MAKES 125 GALLONS. DO NOT EXCEED 100 LB PRESSURE.

**BACK PACK/OTHER SPRAYERS:** 1oz MAKES 3 GALLONS. ADD WATER THEN PRODUCT. SHAKE.

DO NOT DILUTE MORE THAN RECOMMENDED. PRODUCT CAN BE MADE STRONGER FOR HIGHER POPULATIONS OF INSECTS. CAN BE USED YEAR ROUND.

BEFORE SPRAYING, MAKE SURE YOU ARE AWARE OF PATTERNS, BEHAVIORS, LIFE CYCLES, ETC... OF THE INSECT(S) YOU ARE TARGETING FOR THE BEST USE OF OUR PRODUCT.

SPRAY EVERY 15-45 DAYS DEPENDING ON SEVERITY OF INFESTATION. EVERY 60 DAYS FOR MAINTENANCE EARLY SPRING - LATE FALL. NOT RECOMMENDED FOR FRUIT TREES OR EDIBLE CROPS.

FOR TICKS & MOSQUITOS: FOR BEST RESULTS SPRAY WOOD PILES, STONE WALLS, UNDER SHRUBS, LEAF PILES. ALL SHADED, COOL AND MOIST AREAS. ALLOW 15 MIN FOR DRYING TIME BEFORE RE-ENTRY.

TRIPLE RINSE BOTTLES BEFORE DISPOSAL. CUT CAPS AND PUNCTURE CONTAINER.

STORE UNUSED PORTION IN A COOL DRY PLACE OUT OF SUNLIGHT AND NOT BELOW 32°F.

### COVERAGE:

TRUCK/TANK SPRAYERS: 1 GALLON OF READY MIX COVERS 1000 SQUARE FEET.

BACKPACK/OTHER SPRAYERS: 3 GALLONS OF READY MIX COVERS APPROXIMATELY 1/2 ACRE.

**ACTIVE INGREDIENTS - CEDAR OIL (47.7%), 2 PHENETHYL PROPIONATE (15.3%).  
INERT INGREDIENTS - SOAP BARK, ETHYL LACTATE (37%).**
